- **Item 2. Chief Executive's report:** Francis D'Souza (FD'S) shared reflections on 2021, recognising the hard work and resilience of staff in the face of another challenging year. FD'S reflected on the key themes of Gwen Hines' (GH) CEO report, with impact for and with children at the forefront. The Board also noted the KPIs for the 2022-2024 strategy, as well as plans for the 2021 Annual Report.
- **Item 3. Christmas Cheer:** Gemma Sherrington (GS) acknowledged the hard work of the teams working in the shops, as well as volunteers across the UK, and reflected on the success of the 2021 Christmas Jumper Day.
